

## BOXFORD PARISH COUNCIL

MINUTES of the MEETING held on Tuesday 22<sup>nd</sup> July 2025 at 7.00p.m. in the Village Hall, Boxford.

**PRESENT:** Cllrs D Warren, H Watts, C Lawson, P Watt. Z Rumsey (Clerk), DCllr Hurren (arrived at 20.10), Victoria Poole, James Tolputt and Andrew Troke were in attendance to be co-opted to the Parish Council and 4 members of the public attended in person.

**1. Election of Chair:**

Cllr Warren was nominated as Chair, this was proposed and seconded. This was voted unanimously; the Declaration of Acceptance of Office as Chairman was agreed to be signed prior to the next meeting.

**2. Co-Option of Councillors:**

Victoria Poole, James Tolputt and Andrew Troke were nominated to be co-opted to the Parish Council, this was proposed and seconded and voted unanimously to co-opt all three members. The Declaration of Acceptance of Office was agreed to be signed prior to the next meeting.

**3. Election of Vice Chair:**

There were no nominations for Vice Chair. It was resolved to carry forward.

**4. Resignations:**

It was reported that Kevin Couling and Vince Strafford have formally resigned from the Parish Council. Notice of vacancy has been advertised for one position and BDC will be notified of the other resignation for an additional notice of vacancy.

**10. District Council Report:**

These matters were raised with DCllr Hurren upon arrival. It was also requested that a schedule is received for the village road sweeping to ensure residents are aware in a timely manner. DCllr Hurren also reported on the Local Government Review and the Spending Review where the Neighbourhood Planning grants have been scrapped. DCllr Hurren also advised that the Woodland Trust are waiting for the hand over of the footpath at Goodlands, it is with solicitors.

## 13. Planning – Report on Decisions from the Planning Authority.

a) DC/25/02652 – Simbos Gun Dogs & Grooming, Stone Street, Boxford – Full Planning Application  
- Change of use and conversion of outbuilding into a new annexe. Concerns were raised regarding the previously refused applications, it was felt this is an underhand way of getting permission, could this open the floodgates for other potential development in the area. It was also noted that the development is on a flood plain. It was resolved to raise an objection based on these comments.

b) *Any other urgent planning matters:*

**14. Cemetery and Churchyard**

BDC has informed that additional traffic controls will need to be in place for the Churchyard wall repairs. This may take us over budget, it was resolved to go ahead as planned. This is due to take place in the first week of August.

An estimate is being sought for the tree works in the cemetery, this will be prepared for the next meeting.

**16. Public Realms**

The new members of the Council were informed of the ongoing process with the yellow lines in the village. SSC have now been paid for the works, a timescale is yet to be set.

**17. Appointment of Sub Committees and Representatives**

It was commented that the need for individual subcommittees for the various areas is obsolete and may be better to focus on individual tasks, such as the car park, the croft etc. It was resolved to arrange a meeting with all members of the PC to go through all current tasks with the new members and make a plan for individuals to take responsibility or be a representative. This will be reported at the next PC meeting.

## Report for Boxford PC 22nd July 2025 by Cllr Bryn Hurren

First of all there has been some progress on the Local Government Review (LGR) while we now have been told that their will now be Mayoral elections across Norfolk and Suffolk on first Thursday of May 26, there has now been some progress on the unitary authorities as well, with all District Councils across Suffolk and Norfolk opting for three unitaries across each county, these proposals are currently going before each DC to be ratified before being presented to government. ( BDC Tuesday Evening.)

One shock within the last spending review was that the monies for Neighbourhood plans were to be scrapped completely, unless one had been started and was in current progress. BDC has reacted to this by amending the CIL rules to include NP within the remit for village neighbourhood CIL. This means that a revamp for an existing plan is acceptable for grant funding.

The biggest problem in BaberghmidSuffolk is the terrible homelessness that now is upon us and in the villages as well as the more urban areas, the collapse of the private sector rental function is making the situation much worse and everything that the councils have is now full and in a log jam, although the RTB is now at an end, it is 30yrs too late. Also in the long period of LGR it will be impossible for our housing function and councils to trade in the normal way.

We have received a request from CC to install EV charging points at Homefield. Might be good to know Boxford PC views.

Negotiations continue with developer to bring pressure to bear to get Primrose meadow handed over to the Woodland Trust, I have asked our planning team to step up the pressure on them to aid a swift transfer. So much to do there.

I have full council this evening but will do my very best to rush back before the end of your meeting to answer any questions that you might have.
